The City of Hickman is putting together a steering committee to begin updating its 2007 Comprehensive Plan and is seeking interested community members to join in the process. A 17-19 volunteer member Comprehensive Plan Steering Committee (CPSC) will be formed to help guide the update with the City Planning Commission and Staff. The Comprehensive Plan will establish a long-range vision for Hickman, define community goals and objectives, and provide guidance for implementing programs and policies for the City's future growth and development.

An informational meeting will be held Thursday, October 8, 2015 at the Hickman Fire Hall. Anyone interested in volunteering is welcome to attend. The CPSC will meet every 2nd Thursday for approximately 8 to 10 months. It is anticipated that the CPSC will have one two-hour meeting per month with an estimated six hours of review, comment, and preparation time in-between meetings. - Have you changed your smoke detector batteries this year? Do you have an escape plan?



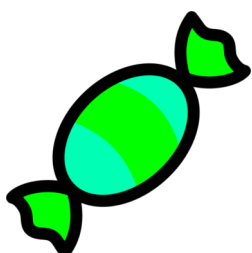
Be A Good Neighbor
