The 9th Annual Trick or Treat on the Trail is scheduled for Thursday, October 27th, 2016 from 6:00 pm to 7:30 pm.


The fun starts at the trail entrance on 1st & Walnut Streets.

City of Hickman Holds Tax Rate

On September 13th, 2016 the City Council held a budget hearing and voted to hold the Property Tax Rate for Fiscal Year 2016/2017 at the same rate as Fiscal Year 2015/2016. The total combined general tax and bond tax rates were set to 0.645324, which is a 7.3 percent decrease compared to Fiscal Year 2014/2015. The City of Hickman has worked diligently to keep the tax rate flat or decrease appropriately while continuing to encourage smart growth of the city. By holding the tax rate flat, the City has requested to receive a total of \$825,076 from property taxes which is an increase of \$34,421 from Fiscal Year 2015/2016, and is a result based on property valuation increases by Lancaster County Assessor.

- Make sure you know how old all the smoke alarms are in your home
- To find out how old a smoke alarm is, look at the date of manufacture on the back of the alarm; the alarm should be replaced 10 years from that date.


