

### **Annual Registration Requirements:**

Completed Registration Form \* Proof of Insurance \$25 Registration Fee \* Bicycle Safety Flag **Basic Rules:** 

City Issued registration sticker must be displayed on the rear of the golf car Cannot be parked or driven on any city trail or sidewalk Operation on streets that are posted for 35 miles per hours or less Operated only between the hours of sunrise to sunset Speed should not exceed 25 miles per hour

Operator must have a valid Class O operator's license

# WAIT! What about my ATV/UTV? Yes—You can drive those too! (ORD2008-12)

No Registration Requirements at this time, however,

the following Basic Rules are in effect:

Equipped with electric strobe/flashing beacon on top of the vehicle OR a bicycle safety flag

Equipped with operational brake light

No operation on highways, but crossing of the highway is permitted Operated only between the hours of sunrise to sunset OR Must have operational headlight, taillight and visual brake light system

> Speed should not exceed Posted Limits and in no event exceed 30 mph Operator must have a valid Class O operator's license

Passengers only allowed in vehicles specifically designed by the manufacturer for the operator and passenger(s)

> Operator & Passengers must wear a helmet Proof of Liability Insurance

# Get a City Building Permit Before You Start Your Home Improvement Project

To ensure building safety the City of Hickman requires a building permit for most home improvement projects, including sheds and fences.

Building permit forms are available at the City Office or can be emailed upon request.

All permits must be approved before work begins.

Structures or changes to structures without a building permit shall be deemed and considered a public nuisance and may be abated or removed by the City at the expense of the owner.

# UTILTY BILL TIP OF THE MONTH REFRIDGERATOR EFFICIENCY

## Here are some ideas to help you reduce energy costs:

If your second refrigerator is more than 10 years old, try moving all your refrigerated items into one unit; preferably, your newest. Refrigerators are the most efficient when they are kept full. Confirm that air inside the refrigerator can flow around all items to ensure proper cooling.

Only plug-in and operate the second refrigerator when you know it is needed.

If you are hosting a large celebration, turn the unit on a few hours before the event and unplug it after it is no longer needed. Consider loading a cooler up with ice if the extra room is needed for a brief period. The cost of running your old refrigerator over a 48 hour period can often be offset by the cost for a bag of ice.

Clean the coils on all of your refrigeration yearly. Clean them more frequently if the unit is in a dusty or dirty environment. Do it for your new unit, too!

If you really need a second unit, consider purchasing a compact unit that is ENERGYSTAR qualified. These units will consume only a minor portion of the energy a 30-year old unit.
