#### Terms of Agreement

#### Payment Notice, Payment Date and Billing Questions

You will continue to receive a monthly statement which is sent out on the last working day of the month. You will have until the 15<sup>th</sup> of the month to contact us if there is a dispute or question regarding the bill. On the 20<sup>th</sup> of each month the payment will be deducted from your account. If the 20<sup>th</sup> falls on a weekend or holiday, your account will be charged on the next business day. *Availability of Funds* 

You are responsible for having enough money in the indicated account on the payment date. If the transaction cannot be processed for any reason, a notice will then be mailed to you and the payment must be made at our office by cash or check. You will be responsible for all fees charged should your payment be returned for any non-payment reason, this will include a \$ 45.00 Non Sufficient Funds (NSF) fee and late charges. Also, your automatic bank payment service may be cancelled if two payments are returned in a 12 month period for non-payment.

#### **Record of Payment**

The amount and date of your automatic payment will be shown on your regular bank statement. This is your proof of payment. If there is a question about a payment or if the amount differs from your bill for any reason, you must notify us and your bank within 60 days of the date on which the error is first reflected.

#### Account / Address Change

Please notify us of any account or address changes to ensure timely payments. You are responsible for submitting a new authorization agreement for direct payment form when an account or address change occurs.

#### Termination

This authorization will remain in effect until we receive a written notice from you 5 days prior to cancellation date or until your service has been terminated and the final bill is paid in full. You may cancel automatic bank payment service (ACH) by written request or stop by our office and fill out a form.

# **Utility Services**

The Water and Sewer utilities are billed monthly and operated by the City of Hickman. Meters are read on or around the 18th of the month. Bills are calculated and mailed on the last business day of each month, and due in full by the 20<sup>th</sup> of the following month. Accounts are deemed delinquent and assessed a 10% penalty if payment is not received in the City Office by the 20<sup>th</sup> at 5:00 p.m. There is a Utility Service application process and a \$100.00 utility deposit on all utility accounts. The City accepts cash, checks/money orders, credit/debit cards and ACH Direct Payments (form available in City Office). A utility payment drop box is located by the front door of the City Office for making non-cash utility bill payments. You can also pay online: www.hickman.ne.gov, click on the City Utilities tab.

# Reading, Historical & Tech Centre

The Hickman Reading, Historical & Tech Centre is located at 115 Locust Street. Large selection of fiction and nonfiction for adults and children are available for check out. # **Recreation and Park Activities**

Hickman has several parks located in the city.

Main Park is located on 2nd Street and offers playground equipment, tennis court, basketball court, sand volleyball pit, park shelters with grills, and baseball and softball fields.

Prairie View Park is located on Sunflower Drive and offers playground equipment, basketball court, and park shelter.

Prairie Park with playground equipment is located on East 4<sup>th</sup> Street Circle.

Craig Dodge Memorial Park is located on 4<sup>th</sup> and Main Street and offers park benches. Hiking and biking trails are located throughout the City.

The City offers organized youth baseball, softball, and soccer programs throughout the year.

# **Building Permits**

No person, firm or corporation shall erect, construct, enlarge, alter, repair, move, improve, remove, convert, or demolish any building, structure, swimming pool, or parking lot in the City or within one mile of the corporate limits of the City or cause the same to be done without first obtaining a building permit from the City Clerk (Section 9-201 Municipal Code). Contact the City Codes & Zoning Director at the City Office for further information & permit applications.

## **Digger's Hotline of Nebraska**

Digger's Hotline - 1.800.331.5666. A 48-hour notice (not including weekends or holidays) is required before digging begins. All underground cable companies will be contacted, and the lines will be located and flagged to avoid cutting electric, gas, phone or cable TV lines.

## Hickman Area Community Foundation & Other Civic Groups

The Hickman Area Community Foundation, Kiwanis Club, American Legion Post 105, and Hickman Rural Volunteer Fire Department and Hickman Chamber of Commerce helps plan many activities in Hickman. Please call the City Office if you are interested in volunteering for any of these groups.

## <u>Dogs</u>

Any person who shall own, keep, or harbor a dog over the age of six months within the City, shall within 30 days after acquisition of the said dog, acquire a license for each such dog annually by or before March 31<sup>st</sup> of each year (Section 3-204 Hickman Municipal Code). Dog licenses are available at the City Office.

## Sewer Back up Notice

The City of Hickman follows a regular sewer line maintenance program. Sewer back-ups can still occur. Please call the City Office 402.792.2212 if you suspect a sewer back-up in your home.

# Inoperable/Unlicensed Vehicles and Trailer Parking

It shall be unlawful to park any trailer, self-propelled mobile home, bus, tractor-trailer, semi-trailer, or any vehicle which exceeds 20 feet in length or seven feet in width on any street in the City for over two hours (Section 4-211 Hickman Municipal Code).

Vehicles kept on any property, private or public, must be both licensed and operable. Vehicles that are partially dismantled, wrecked or junked are not allowed to remain on any property for any length of time. Trailers may not be parked on any street in the city for more than two hours. Please do not obstruct intersections or sidewalks.

## **Burn Permit Information**

Burn permits are allowed outside of the city limits only (no burning allowed within city limits). Local, County, and State Government agencies will be governed by the windspeeds (must be less than 10 mph). There is no allowance for burning anything but 'natural state' materials. For example, no tires, sawn or finished lumber, shingles (asphalt, wood, or fiberglass), siding or building debris. If weather conditions are extremely dry, there may be a ban on all open burning. Burning without a proper permit may result in a Class IV misdemeanor charge according to Nebraska Statute 81-520.01, 81-520.2, 81-520.3 to 81.520.5.
