- ☐ 2023 Assessed Valuation 330,351,046
 - > 25% Growth (+26,882,900)
- ☐ Utilizing Growth
 - Property Tax Request Increase of 25%
 - Operating Budget increase of 46%
- □ Tax Rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property would be \$0.480417 per \$100 of assessed value.
 - Example:

 $$100,000 \times 0.598137\% = 598.14 $$124,504 \times 0.480417\% = 598.14
